Overview



- It's all about your WHY?
- Choose your location based on where you want to study abroad
 - ▶ **There is not a dedicated business program.**
- You may submit applications for only **2 locations.**
- Study Abroad is a competitive process
 - ▶ not all students will be accepted

Summer Study Abroad Applications

- Summer study abroad applications opened September 1st
- Same deadline as the semester applications of November 1st.
- No approvals required
- You can apply to both summer and semester programs.
- **Summer program applications won't impact semester program decisions.**





Key Factors to Keep in Mind

- Your personal statement is the important part of your application. This is how you distinguish yourself. This is your WHY.
- Fall semester grades weigh in the decision
- Serious Community Standards violations impact decision
- Minimum for Mendoza is 2.5 (cumulative). Some programs have higher GPA requirements.

Application Requirements

- Application link is found on each program page on the study abroad website
- Part of the application process is that you must receive approval to study abroad from your DUS and your Dean.
- For Mendoza College of Business Students your 1st DUS is one of the following advisors based on your last name:
 - ▶ **A-D** Amy Radvansky
 - ▶ **E-K** Lisa Heming
 - ▶ **L-Q** Jen Washko
 - ▶ **R-Z** Gina Shropshire
- Your 2nd DUS would be the person in charge of your 2nd or supplementary major (if applicable).
- **Your Advising Dean is Andrew Wendelborn.**

Application Requirements

We will add DUS and Dean's approval based on:

- Your GPA is above 2.5 and you are not on academic warning or probation.
- The study abroad semester fits in your 4-year plan of study and you can complete all graduation requirements.
- You have opened your Study Abroad applications in the system so that we can add our approvals.

Logistics

- Do not email your Advisor/DUS and/or your Dean to let us know about your application or to request approvals. We are automatically notified that your application is awaiting approval.
- Your deadline to submit applications is **November 1st**, but our deadline to submit approvals is **December 1st**. Please be patient.



DEADLINES

- **November 1st** – Your fully completed application must be submitted.
- **December 1st** - Mendoza approvals for all open applications will be completed by **your Undergraduate Advisor/DUS and Dean.**

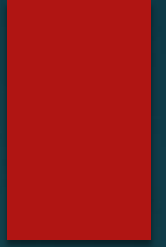

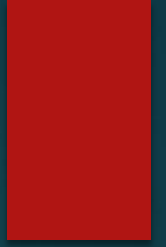


Study Abroad Courses

- ▶ If business courses are available, you may take one (1) major course.
- ▶ You might find courses that count in your 2nd major or minor. You must confirm with THAT department that these courses count and how many courses they will accept.
- ▶ Many locations have REQUIRED courses. Be sure you factor those into your plan.
- ▶ You should not plan to take more than 15-16 credits during your semester abroad.
- ▶ It is possible that you can take University Core Requirements while abroad.
- ▶ **Most students take elective courses abroad. That's the best plan.**

Next Steps and Additional Information

- **You do not have to meet with an advisor for study abroad approvals.**
- Study Abroad Week begins Monday, September 25th.
- Questions about your personal statement, mistakes on your application, or technical difficulties should be directed to the **Study Abroad Office**.
- 2nd major or minor questions - contact that advisor.
- Do your homework – find out if your program requires language study before you go and at what level. These courses might need to be built into your Plan of Study in sophomore year.

Reminder of deadlines

- **November 1st** – Your fully completed application must be submitted in the system to Study Abroad.
- **December 1st-** Mendoza approvals for all open applications will be completed by **your Undergraduate Advisor/DUS and your Advising Dean.**
